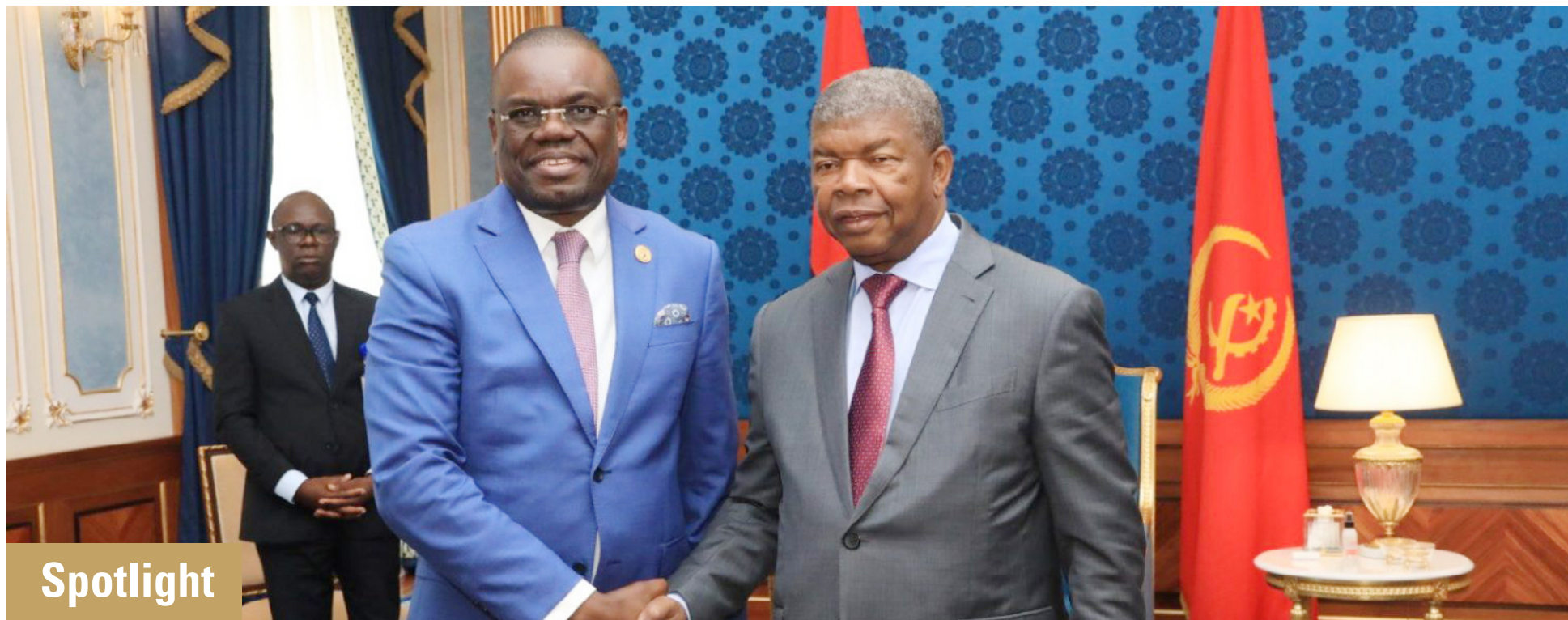

## Angola's President Pledges \$5 Million to Africa CDC to Strengthen Continental Health Security

### A landmark act of solidarity to advance sustainable health financing across Africa

In a landmark move for Africa's health future, H.E. João Lourenço, President of the Republic of Angola and Chairperson of the African Union, announced a voluntary contribution of USD 5 million to the Africa Centres for Disease Control and Prevention (Africa CDC). The announcement follows a high-level meeting with Dr. Jean Kaseya, Director General of Africa CDC, on 21 April 2025 in Luanda.

Dr. Kaseya hailed the pledge as a bold and historic commitment, stating, "President Lourenço's lead-

ership reflects Africa's collective determination to finance our health future with African-led solutions."

President Lourenço further committed to convening a Committee of African Heads of State to champion the continental health financing strategy, "Rethinking African Health Financing in a New Era," in response to declining global development assistance.

Africa CDC also announced support for Angola's plan to locally manufacture mosquito nets, expanding

regional production capacity for essential health commodities. Discussions also focused on Angola's cholera outbreak response, with Africa CDC pledging full financial and technical assistance.

This announcement marks a major milestone in Africa CDC's drive to advance political leadership, sustainable financing, and continental solidarity under the New Public Health Order and the Lusaka Agenda.

### Africa CDC Commends Uganda on Declaring the End of its Eighth Ebola Virus Disease Outbreak



### A milestone in public health resilience and continental collaboration

Africa CDC commends the Republic of Uganda for declaring the end of its eighth Sudan Ebola Virus Disease (SVD) outbreak after 42 days with no new infections. Strong leadership, swift action, and community engagement were critical in achieving this milestone, with all admitted patients recovering and safely reintegrating into their communities.

In support of the national response, Africa CDC deployed 15 emergency specialists, trained 897 community health workers and 80 surveillance officers, and deployed 40 IPC mentors to

high-risk districts. Laboratory capacity was strengthened with field diagnostic kits, and extensive risk communication activities were carried out.

Africa CDC's ongoing support focuses on future preparedness through research studies, a genomic sequencing machine, and the delivery of \$4.3 million worth of emergency supplies and cold chain equipment.

Together, Uganda's leadership and Africa CDC's collective efforts highlight the strength of collaboration in safeguarding public health across the continent.

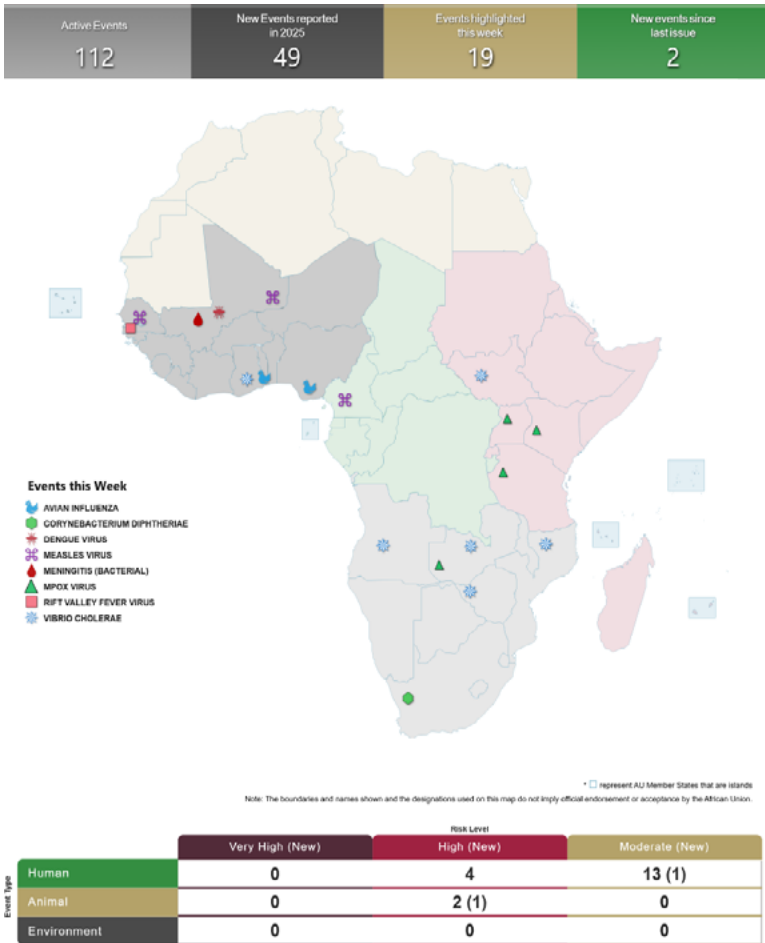


## Africa CDC Epidemic Intelligence Weekly Report: April 2025

### Call for Bold Health Financing at Pandemic Fund High-Level Roundtable

Spearheading sustainable investment and continental resilience

At a high-level roundtable hosted by the Pandemic Fund on the margins of the World Bank-IMF Spring Meetings in Washington, D.C., Africa CDC called for urgent action to rethink Africa's health

financing architecture. Dr. Jean Kaseya highlighted the continent's worsening financing gap, with official development assistance declining by 70% and a looming \$81 billion debt burden.

Africa CDC emphasized its leadership role through the AU-endorsed "Rethinking Africa's Health Financing in a New Era" strategy, the upcoming AU Health Financing Forum, and the Africa Epidemics Fund (AfEF), which aims to secure rapid, transparent financing for health emergencies. Dr. Kaseya also underscored Africa CDC's operational advances through its Incident Management Support Team (IMST) and collaboration with WHO under the Joint Emergency Action Plan (JEAP).

Commending the Pandemic Fund's \$321 million funding for Africa through the second call for proposals, Africa CDC reiterated its commitment to country systems strengthening, regional collaboration, and building resilient, African-led health security solutions.
